The victims were not registered youth members nor were the incidents conducted on any Scouting vicinity. At the time, this troop took action to sever his relationship. Nerau has been in jail since originally arraigned.

Recently, I was informed of the disposition of his case. He was found guilty and is serving a sentence of 1 1/2 to 4 1/2 in State Prison and undergoing psychiatric treatment. He should be placed in the ineligible volunteer files.


Dear Alan,

**Baby sitter faces
50 sex charges**

A Rochester man who baby-sat two children was arraigned yesterday on more than 50 sexual abuse and child endangerment charges after police accused him of molesting the children, according to a criminal complaint.

Alvin Nerau, 22, whose last address was on North Street, was charged with 27 counts of first-degree sexual abuse and 29 counts of endangering the welfare of a child. He was ordered held in the Monroe County Jail on \$25,000 bail.

Police accused Nerau of sexually abusing a 9-year-old boy and a 6-year-old girl numerous times in February.
