*Clothier Charged With Attack on 2 Teen Girls

Huntington—A Huntington businessman was arrested this weekend on statutory rape charges involving two 17-year-old high school girls who worked as [redacted] in [redacted] men's clothing store.

Police said Henry Van Baalen, 41, enticed the girls, whose names were withheld, to have sexual relations with him by promising them salaries of from \$80 to \$100 a week at his now defunct Swager Set Inc., a men's clothing store at 300 Main St. Police said Van Baalen, who gave his address as 59 Markan Dr., Northport, hired the girls after asking a young clerk who was asked to provide him with the names of young girls who were looking for secretarial work. Van Baalen was arraigned Saturday before District Court Judge Frank P. DeLuca on two charges of second-degree rape and was released in \$2,000 bail for examination tomorrow.

Authorities described the girls as high school students, one from Nassau and one from Suffolk. Both were described by police as coming from good homes. "They certainly didn't need the jobs," said one police officer. Police said Van Baalen also promised the girls to buy them cars and to train them as clothing buyers. Police said the girls worked for Van Baalen for about three weeks but left when they were not paid. The alleged sexual incidents took place earlier this year in the town of the girls.

police said. They said they learned about them from a third girl who had heard the story indirectly.

Van Baalen was also arraigned Saturday on a charge of issuing a fraudulent \$444 check to the Huntington Horn House for a party for one of his sons earlier this year. Police said that Van Baalen is married and has five children. He faces 10 years in prison on the charge and up to one year on the \$444 check charge.

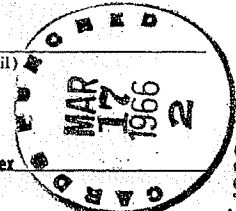

Dear Bill:

I have a most interesting situation to share with you. Your office sent us an application for a new Troop 213. The boy roster claims only two boys, Guy Van Baalen and Ralph Van Baalen. The adult roster includes a Hank Van Baalen, Jr., shown as the Committeeman and Henry Van Baalen, Sr., shown as the Scoutmaster. There is obviously an error shown in the two Henry Van Baalens' ages. The application shows both Jr. and Sr. as age 45.

The clincher in this whole deal is that we have a Henry Van Baalen, Sr. on the Confidential File. We are quite sure that our Henry Van Baalen and your Henry Van Baalen are one and the same individual. However, to make doubly sure, we are enclosing with this letter an Identification questionnaire with characteristics for you to check.

Our confidential file record shows that in 1966 Henry, Jr. was 13 years of age. This would make him 17 or 18 at the present time. If this is so, he is not eligible to be a Troop Committeeman. A Committeeman must be 21 years of age.

After you have investigated this rather unique situation, please advise me as to what we should do with this Troop. We will hold it pending until further word from you.
