WADDINGTON — A Waddington man was charged with second-degree sexual abuse following a complaint that he had been involved with a young child.

Richard A. Condlin, 34, of Waddington, was arrested by St. Lawrence County sheriff's deputies on a warrant issued by Judge Robert McKnight.

He was released on his own recognizance following arraignment.

Deputies would not release any other information about the incident.

Complainant states that her son, [REDACTED] age 11, is a member of the Scout Troop in Waddington and her neighbor, Richard Condlin, is the Scout Leader and she feels that there is more that Scouting going on between her son and Mr. Condlin. She has learned that Mr. Condlin goes to the Waddington Elementary School and checks on [REDACTED] often and the principal of the Elementary School can confirm this. Mrs. [REDACTED] does not know if there has been any physical contact between the two and is afraid to talk to [REDACTED] about it for fear of hurting him pschologically. Det. Sgt. Germano has been made aware of this and will investigate further. PR

Interviewed [REDACTED] and established that there had been some sexual contact. Also interviewed Richard A. Condlin.
