She advised over the phone that Richard Watterson admitted to her that he sexually molested her son, [REDACTED], on the 14th of July at his home. At the time he admitted to the offense, he was in the presence of an off-duty Bal Harbour Police Detective, Sam Goldstein. Mrs. [REDACTED] came to the Station and signed a Non-Prosecution Form on July 18, 1977 in front of Notary Joel Lack. Officer Lack is a Police Officer with this Police Department. A phone call was placed to Detective Sam Goldstein, Bal Harbour Police, at 866-4633 by this Detective. He related the same information which Mrs. [REDACTED] advised me of. He also stated that he was [REDACTED] Big Brother in the Big Brother Program. After obtaining the information from Mrs. [REDACTED] a phone call was placed to Scout Headquarters 446-8431 where I talked to a Scout Executive, Mr. Will Fuller. Mr. Ort related information that subject Richard Watterson's card would be picked up by the head of the committee of his troop, Ed Janofsky, and that the subject would be expelled from Scouting throughout the nation. A phone call was placed to the State Attorney's Office, Thomas K. Petersen, at 547-7060 and an appointment was set up for the following day, the 19th, 1977.

19 July 1977, at 10:50 A.M., in Mr. Thomas K. Petersen's office information reference to this case was relayed to Jim. After conferring with Mr. Carr of the State Attorney's Office, they decided that the mother and son would be subpoenaed into the State Attorney's office as soon as the son returned from camp, and if the information was correct, a warrant would be issued for Rick Watterson's arrest under the Florida State Statute 800.04 for Lewd, lascivious or indecent assault or act upon or in presence of child. After checking the schedule it was decided that the mother and son should be subpoenaed for August 4, 1977, Thursday, at 10:30 in the morning.

I appreciate the point you raised in your letter of February 14 concerning the registration of Richard Crain Watterson. However, one basic fact remains unchanged.

This is that his application for registration was submitted by him as an Assistant Scoutmaster in Troop 953, District 9 of the Allegheny Council. This is your council, and even though he may be currently serving in Europe in the armed forces, his registration application is through Allegheny Council. The fee was submitted to us through your council and we have no choice but to return the fee to you since we are unable to accept his registration as submitted by Allegheny Council, not as submitted by Transatlantic Council.

I am very sorry but I do not see how we can justifiably ask the Transatlantic Council to write to Mr. Watterson when his registration is not through Transatlantic at all, but is completely through the Allegheny Council.

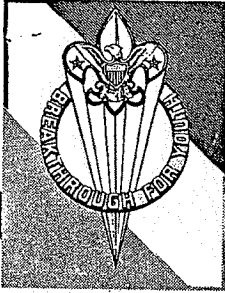

1. Reference is made to our recent discussion pertaining to the former Scoutmaster, ALC Richard Cremin Watterson. As I advised you at that time, Airman Watterson had previously been assigned to Chateauroux Air Station where he was active in the Boy Scouts. There one of the mothers had occasion to complain of Airman Watterson's action with her two sons. She indicated that Watterson, who had been a frequent house guest, slept, on numerous weekends, at their residence. The mother had received a warning from a person she declined to identify in October 1965, that Watterson had been acting funny with the boys in the Scout Troop. The mother then questioned her two boys and they indicated that Watterson had touched their private parts when he was a house guest and also at scout camp-outs. In questioning the boys, the one son, age 8, said Watterson had tickled his "dinky" whenever they had slept together. He also stated that his older brother had told him that Airman Watterson had played with him also at scout camp-outs. When the boy was questioned again on a matter of record, he repeated the same statements, but added that Watterson had told him not to tell anyone. On a subsequent interview, while the boy's father was present, the boy stated that each time Watterson had slept in the same bed with him that the Subject would place his hand inside the boy's shorts and move his hand up and down on the boy's private parts. Subject requested the boy to reciprocate the act and when the boy refused, subject would take the boy's hand, place it inside his (Watterson's) shorts and move the boy's hand up and down on his private parts.

2. When the older boy, age 11, was questioned, he stated that on five or six camp-outs that he had attended, Airman Watterson always wrestled with the boys and tickled them. On one occasion, after the telling of ghost stories, he and Watterson shared the same sleeping bag at Watterson's suggestion and on another occasion when the boy's sleeping bag was too wet to sleep in. On both occasions, Watterson had touched the boy's private parts. On yet another occasion, while wrestling, Watterson took the boy's clothes off and carried him outside the tent to embarrass him.

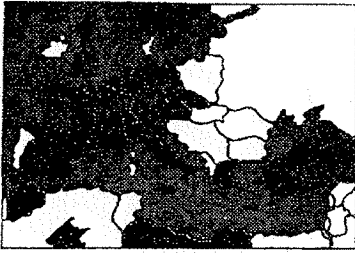
3. A woman friend executed a sworn statement on 2 November 1965, to the effect that when she went to the camp site where her two boys were participating in the camp-out, she saw feet kicking around and heard giggling from one of the pup tents. She stated that Airman Watterson came out of the tent wearing a bikini swim suit and that it was quite obvious to her that he had an erection. While she was talking to him, another car drove up and Watterson went over to speak with them. Meanwhile, a boy, who she did not know, came out of the tent that Airman Watterson had been in.

4. On 17 November 1965, after Airman Watterson had been read Article 31, UCMJ, advised of his rights and the nature of the investigation, he executed a sworn statement stating that he had in fact slept in the above mentioned mother's house and that the younger boy and himself had slept together and had generally "horse played", but he denied having touched the boy's private parts. He also admitted that during a camp-out he had slept with the older boy and that they had "horse played", but that he did not knowingly touch the boy's private parts.

5. For your information, Watterson goes by the name "Dick". He is 72 inches in height, approximately 166 pounds, brown eyes and brown hair, caucasian with no distinguishing marks.

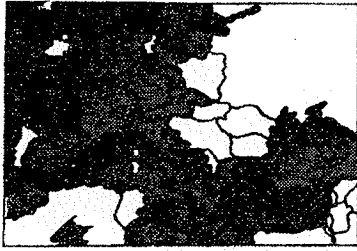


