## Green Light To Sign Pact

**CANTON** — After weeks of trying to hammer out agreeable wording in a contract for St. Lawrence County workers, County Legislature Chairman Lloyd E. Moger was authorized Monday to sign the newly-ratified three-year accord.

However, two lawmakers who were on the committee that negotiated the contract opposed the move. "The difference is in overtime," Robert L. Snider, R-Star Lake, said. "I'm not too sure it was what was negotiated."

"It looks like we might be going to arbitration over a small amount of money," he said, implying the Civil Service Employees Association may not go along with the final wording of the contract.

The 19-2 vote by the board of legislators came after a nearly 1 1/2-hour executive session called by Legislator and Finance Committee Chairman Bennett H. Abrams, R-Massena.

"They want to know if this was the same contract they voted on in negotiations," County Atty. William F. Maginn said.

Mr. Snider said Monday the differences in language could amount to a 2-percent difference in overtime pay for county workers. However, he declined to discuss the differences in detail.

The contract was ratified by both the county and the Civil Service Employees Association in February and March.

**CANTON** — St. Lawrence County Judge Eugene J. Smith has dismissed an indictment against a Governour man with setting fire to a third-degree arson charge.
