I have been advised of my rights under the Miranda Warning and want to say that I understand all of my rights and I am making this statement to Det. Mark Favret, Det. Frank Derrigo, and Det. Robert C. Pooler of the Watertown Police Dept. after having read my rights from the card which Det. Pooler gave me.

I want to say that four or five years ago I began helping with his Boy Scout Troop #12 which had their meetings at either watertown High School or at Wiley School. The meetings would take place at either place while school was on. Sometime during this period I met About two or thr.. -ee years ago things started happening between me and was living I think that it was apartment # I wanted some first hand experience before he turned into an adult. Before the anything had happended I put my hand on had happended I put my hand on less leg somewhere near his crotch. I put it there just kinda goofi' around, but he took it that I wanted to have sex with him. I didn't want to disappoint him so he pulled his pants down and I put my hand on his dick.and started jerking him off. After 4 or 5 minutes of this I pulled down my pants and let him start jerking me off. The only reason I ,let him do this was because he asked me lif he could. came while I was jerking him off. I didn't come until I finished myself off. We then talked for a litwhile and then we both fell asleep. This was in bedroom on p/~ ..

I tried to spend at least one night a week with so I could teach him the difference between right and wrong before he became a man. This jerking each other off happended probably about 10 times over the last 2-3 years. The last time we jerked each other off was at house on About a year or so ago moved to at night.

About two or three months ago I was at and we would talk to his mother and his sister or who ever happended to be there and then go to bed for the night. Would take off his clothes and I would try to keep my under shorts on but they would end up coming off. This night, we had been talking about Boy Scouts and we had all our clothes on. This was in bedroom. Put his hand on my dick outside my pants and started playing with me. He rubbed me for just a second or two. Then we went back out and talked to his Mother. I was about half asleep and the next thing I know my hand is on his dick and his hand is on mine. We then started jerking each other off came but I didn't. We then went back to sleep.

A couple of months ago in bedroom we had our clothes off and tried to put his dick in my butt. He tried to do this 3 different ways. First I would draw my knees up under me and he tried to put it in my butt, but it didn't work. Next he had me try to sit on his dick but that didn't work either. The last way he tried it was with me lying on my side. All these times he got his dick in my butt, but it wouldn't stay inside me. He did not come either of the times. I did this because I wanted to teach him the right way of doing and made sure he knew what was going on in the real world.

and I never had any oral sex with each other.

OTE: For page two of statement Det. Derrigo and Pooler are the only ones ent. Det. Favret had to leave on another case.

The second month he came over to spend with me I started jerking him off in my bedroom after we went into my room to sleep. It told me that "it wasn! t working" and asked me if I'd give him a blow job. I did this because I wanted him to learn the right way and show him what he had facing him thru the rest of his years and thru High School. Before I started jerking off he had his under shorts on. After I started jerking him off he pulled his shorts off and I pulled mine off. I then started giving him a blow job on my bed. was on his back and I blew him for about 15 or 20 minutes before he came. I swallowed his come. We then just by went to sleep.

The third moth at my apartment was in my room and I remembered what he said before about the jerking off not turning him on so I just went ahead and gave him a blow job. I laid on his back on the bed and I gave him a blow job for about 15 minutes. Came in my mouth and I swallowed it again. I then got on the bedroom floor and jerked myself.

The fourth month I think it was at apartment in his bedroom. I gave a blow job and he came in my mouth again. I tried to spit it out but I ended up swall owing most of it. After this we got dressed and went out into the living room and talked to his Mother for a while. Then went into his brother's room and went to sleep and I slept in bed.

The next moth we were back at my apartment and pretty much the same thing happened. It laid on his back on my bed and I gave him a blow job which lasted about the same amount of time. This time I swallowed his come. After it was over wanted to know if this was the last time this was going to happen and I told him that there was no problem that everything was alright. After I blew him he jerked me off a little bit and I finished it off by myself.

The last time anything happended was the month of August (1986) which was the last time he spent the night at my place laid on the bed and we had our clothes off. I, gave him another blow job which lasted about the same amount of time. I swallowed it because he asked me to swallow it while I was giving him the b'w job. After the blow job, told me that he enjoyed it.
