At approximately 4:00 P.M. on Monday, 2 August 1961 while driving my car twerd Camp Chappegat I met William Scollay, Assistant Section Director, Delaware, Section, who was driving toward the Section Service Center to find me.

Scout of Troop 26 Brooklyn was his passenger. Hill asked me to park my car and ride with he and Bill introduced me to him to relate to me the incident which had already been related to hill Scollay by Mr Thomas Reilly, D. C. of Eastern District, Brooklyn St.

told me thar on the morning of 21 August 1961 F Barry Halpern, Unit Program Counselor, at Camp Chappegat entered the Onanders. Campsite and asked Scout to talk with him in the Leaders leantee. Went with Barry Halpern and they both sat down on the lower bunk of the double dather bunk in the leantoe.

stated that Barry Halpern then said something about leadership and bullying boys and that he then layed down they telled further and continued that Barry then layed down on the bed stong said asked him if he would like a 'pink belly' said no and further stated that Barry Halpern then proceeded to open the buckle of his pants best and undid the zipper on his pants and then proceeded to handle his 'personal areas'

entered the campsite and Berry Jumped cuttof the bunk and left the leantoe. Bill Scollay and I thanked the box for confiding in us and asked him to return to his campsite and not say a more to envoice else.

Bill and myself then found Barry Halpern and took him to the Delaware Service
Center where Ted Accass was located advised Ted of the incident and we took
Barry to the TMR Service Center a brief consultation between Wint Hartman,
Ted Accas and myself Wint confronted Barry Halpern with the accusation. Wint further
outlined the courses of action available to Barry. Barry, at this point, denied the
accusation. Wint Hartman as led Barry to remain at the TMR Service Center, while I
again, in the commany of Rev. Anthony Paone S.J., Catholic Chaplain at TMR re-interviewed

told us that Scout in his opinion was a good boy and a reliable and honest one the also confirmed the story herein described. It was further stated that Scout of Troop 26 was witness to be situation of that morning Father Paone then separatedly questioned Scout who stated that he had seen Barry Halpern and together in the leantce "doing something bad". It was further discovered that a Tew nights ago Barry had entered the leantce of Scout of Troop 26 Brooklyn woke him up and masterbated him. This boy left camp on Sunday, August 20,1961 along with several other boys who the Scoutmaster had sent home for misbehaving.

Father Paone and myself then returned to the TMR Service Center and grain consulted with Wint Hartman. Father Paone informed Mr Hartman that, in his opinion, the boys were telling the truth. Mr Hartman then asked Father Paone on his advise and recommendations, thanked him and further consulted with Barry Halpern. Bill Scollay had originally been informed of the situation by Mr Thomas Reilly, District Commissioner of Eastern District Brooklyn who had been told by Scoutmaster of Troop 26 since he was seeking advise.

All previous persons having knowledge of the situation were counseled with and encouraged to keep the entire situation in the strictest confidence. Father Paone further agreed to counsel with the boys to reassure them and prevent any boy gossip. Mr Robert I Billington, Scott Executive of the GNYC was informed by Mr Hartman of the entire situation.

Mr Halpern is scheduled to leave the TMR Service Center at 6:00A.M. on Tuesday, August 22,1961 to confer with Mr Ballington and Mr Robert Parkinson at the CNYC Service Center.

KANATATATATA

The Camp Director of Chappegatewas told that Barry Halpern had to leave camp immediately because of a personal crisis and is unaware of the entire situation.
