When a boy or an adult pays a registration fee, he is entitled to membership until the expiration date indicated on his membership certificate.

Separation notices must **not** be sent to the national office at the time of reregistration or for unregistered units.

For a boy transferring to a new unit, submit an additional enrollment to add him to his new unit. This separation notice only separates him from his previous unit, it does not add him to his new unit.
